



# Political Unrest - Kenya

#### **GREEN PEN ANSWERS IN YOUR BOOKS**

# Political Unrest - Kenya

In January 2008, Kenya experienced severe political unrest, similar to that in the video.

As a result of this, UK tour companies suspended visits to Kenya. The country experienced a 73% fall in visitor numbers for the first 3 months of 2008. When the country was considered safe for visitors again in May 2008, Richard Branson, owner of Virgin Atlantic, became involved in promoting the country as a tourist destination.

## Political Unrest - North/South Korea

Political unrest can also bring tourism to a country. A particular example is the DMZ border between North and South Korea, a popular tourist attraction. This helps to generate income for both countries, as well as the potential to open up travel routes between countries.

It is a good way to bring in money, giving tourists a 'unique experience' into what tensions are like between the two countries.

# Passports and Entry Requirements

#### Overview of the eTA application process



 Get your passport, credit or debit card ready, and read the help document.



2. Use the online form to apply. The form cannot be saved. So have your information ready.



Pay \$7 CAD for your eTA right after you complete the form.



or

 Get an email about your eTA application.
 Most applications are approved within minutes.



5. You may need to submit documents before your application can be approved. If this happens to you, an email will be sent with instructions within 72 hours.

Different countries have different entry requirements which affect travel companies. As of August 2018, UK citizens now need to apply for a Electronic Travel Authorisation number before entering Canada.

# Passports and Entry Requirements

Difficulty in getting visas for certain countries like Russia can cause problems.

The Russian government don't like people that work in media visiting the country, and the process to get a visa can be difficult.

#### Visas

You'll need to get a visa before you travel. The <u>Russian Embassy</u> advised in March 2018 that it takes around 20 business days (4 weeks) to process most visa applications.

As part of the visa application process, all applicants based in the UK aged 12 or over will need to visit a visa application centre to submit biometric data (scanned fingerprints). These are located in London, Manchester and Edinburgh. The Russian government has also announced plans to introduce biometric fingerprinting for all foreign nationals, including British nationals, when entering Russia. No dates have been confirmed for this.

On receiving your visa you should check the details carefully including the validity dates and passport number to make sure they are correct. Make sure you're aware of the terms and conditions attached to your visa before you travel. You should adhere to the validity and conditions of your visa while you're in Russia, as the authorities strictly enforce all visa and immigration laws.

If you intend to stay longer, you should arrange an extension of your visa before it expires. Overstaying your visa without authorisation can result in a delay to your departure, as well as the possibility of fines, court hearings, deportation and a ban from re-entry.


